OO/COL/02, Inc. a Florida corporation, executes the following articles of dissolution pursuant to section 607.1401 of the Florida Business Corporation Act:

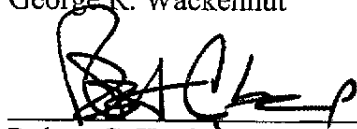
- FIRST: The name of the corporation is OO/COL/02, Inc. (the "Company").

- SIXTH: The company's net assets remaining after winding up the company's affairs have been distributed to the company's shareholders.

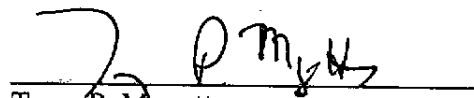
