The name of this corporation is EYE SPY ACCESSORIES INTERNATIONAL, INC.

The term for which this corporation shall exist shall be perpetual.

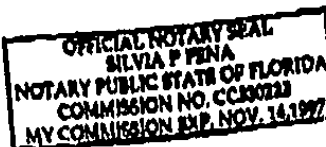
