ARTICUS I. NOME

The name of this corporation is: NAULE TOBACCO, INC.

ARTICLE IL PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business and the general nature of the business to be transacted by this corporation shall include, but not be limited to:

- (a) Manufacturing or causing the manufacturing, distribution and sale and digarettes and other tobacco products under the brand name "Eagla", to process, purchase, well and generally trade and deal in and with commodities and merchandism of every kind and and description; to engage and participate in any mercantile, manufacturing, trading or transportation business of any kind whatsoever; to do any and every act or acts, thing or things necessary or incident to, growing out of, or connected with the usual conduct of such businesses, for the accomplishment of any auch purposes.
- (b) To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services of every class, kind and description.
- (c) To conduct business in, have one or more offices in, and buy, hold mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents,

- (d) To continue debt and borrow money, issue and sell or pladge bonds, debentures, notes and other evidences of indebteduess, and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporate indebteduess as required.
- (a) To purchase the corporate assets of any other corporation and engage in the same or other character of business.
- (f) To acquire by purchase, subscription or otherwise, and to receive, hold, own, guarantee, sell, assign, exchange, underwrite, transfer, mortgage, pladge or otherwise dispose of or deal in and with any of the shares of the capital stock, or any voting trunt certificates in respect of the shares of capital stock, a scrip, warrants, rights, bonds, debentures, notes, trust receipts, and other securities, obligations, choses in action and evidence of indebtedness or interest issued or croated by any corporation, joint stock companies, syndicates, associations, fixms, trusts, or persons, public or private, or by the government of the United States of America, or by any foreign government, or by any state, territory, province, municipality or other political subdivision or by any governmental agency, and as owner thereof to possess and exercise all the rights, power and privileges; of ownership, including the right to execute consents and vote thereon, and to do any and all acts and things necessary or advisable for the preservation, protection, improvement and enhancement in value thereof.
- (g) In general, to do any or all of the things set forth herein to the same extent as a natural person might or could do in the State of Florida or any part of the world as principals or agents, or otherwise, alone or in company with others, without restriction as to time, place or amount, to carry on any other business in connection with the foregoing purposes, and to have and exercise all of the powers conferred by the laws of Florida upon corporations formed under its laws.

ARTICLE III. CAPITAL HTOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is: 7,500 shares at no par value.

All the aforomorpioned stock is to be issued as fully paid for and exampt from assessment.

The capital stock may be paid for in money, property, labor or services, at a just valuation to be fixed by the incorporators or by the directors at a meeting called for such purpose.

The cupital stock is being issued pursuant to Section 1244 of the Internal Revenue Code, the pertinent provisions of which are hereby incorporated herein by reference and made a part hereof.

ARTICLE IV. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE V. INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of this corporation is Sixth Floor McCormick Bldg., 111 S.W. 3rd Street, Miami, Florida 33130 and the name of the initial registered agent of this corporation at that address is Elliott Harris. The board of Directors may, from time to time, move the registered office to any other address in Florida.

The place of business of the corporation shall be at 3501 N.W. 46th Street, Miami, Florida 33142.

ARTICLE VI. DIRECTORS

This corporation shall have Two (2) directors initially. The number of directors may be increased or decreased from time to time in such manner as may be prescribed by the By-Laws, but shall never be less than one (1).

The corporation shall indemnify and hold harmless each person who shall serve at any time hereafter as a director or officer of the corporation, and any person who serves at the request of this corporation, as a director or officer of any other corporation, from and against any and all claims and liabilities to which such person shall become subject by reason of his having heretofore or hereafter been a director or officer of the corporation, or by

reason of any action alleged to have been heretofore or hereafter taken or omitted by him a such director or officer, and shall reimburse each purson for all legal and other expenses reasonably incurred by him in connection with any such claim or liability provided that no person shall be indomnified syminat, or be reimbursed for, any expenses incurred in connection with any claim or liability a to which it shall be adjudged that such officer or director if liable for negligence or willful miscenduct in the performance of his duties.

The rights accruing to any parnon under the foragoing provisions shall not exclude any other right to which he may be lawfully entitled, nor shall anything herein contained restrict the right of the corporation to indemnify or reimburse such person in any proper case even though not specifically herein provided for.

No contract or other transaction between this corporation and any other corporation, and no act of this corporation shall in any way be affected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise interested in, or are directors or officers of, such other corporation; any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of the corporation, provided that the fact that he or such firm so interested shall be disclosed or shall have been known to the Board of pirectors or such members thereof as shall be present at any meeting of the Board at which action upon any such contract or transaction shall be taken; and any director of the corporation who is also a director or officer of such other corporation or is so interested may be counted in determining the existence of a quorum at any meeting of the board of Directors of the corporation which shall authorize any such contract or transaction, and may vote thereat to authorize any such contract or transaction, with like force and effect as if there were not such director or officer of such other corporation or not so interested.
