ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is JOHNS BY JOHN WASTE HAULING, INC.

ARTICLE II - DURATION

As provided in Florida Statutes, Chapter 607, this corporation shall exist in perpetuity.

ARTICLE III - PURPOSE


