

ARTICLE I - NAME

The name of this corporation shall be T. WILKIE & ASSOCIATES, INC., and the address of the principal office of the corporation is 411 Soft Shadow Lane, Debary, Florida 32713.

ARTICLE II - DURATION

The term of existence of this corporation shall be perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of conducting any and all lawful business.
