The undersigned hereby subscribes to these Articles of Incorporation for any legal purpose permitted under the laws of the State of Florida and of the United States of America.

ARTICLE I

The name of the Corporation is: CAFE CUBA, INC.

ARTICLE III

CAPITAL STOCK


