

**FIRST:** The undersigned, President and Secretary of **INTERNET INTEREST INCORPORATED**, a Florida profit corporation formed under Chapter 607 of the Florida Statutes, certify that at a shareholder's meeting held on August 20, 1999, which was called for the purpose of amending the Articles of Incorporation of **INTERNET INTEREST INCORPORATED**, the single shareholder unanimously voted to adopt the following amendments to Articles 1 and 3 of the Articles of Incorporation, pursuant to the provisions of section 607.1006, Florida Statutes:

**ARTICLE 1 - NAME**

The name of **INTERNET INTEREST INCORPORATED** is hereby changed to ***CHEXLR8*, INCORPORATED**, hereinafter referred to as the "Corporation".

**ARTICLE 3 - PRINCIPAL OFFICE**

The address of the principal office of this Corporation and its mailing address are now 7601 East Treasure Drive, #2018, North Bay Village, Florida 33141-4368.

**SECOND:** The effective date of the amendment to Article 1 - Name is August 20th, 1999 and the effective date of the amendment to Article 3 - Principal Office was May 5th, 1999.
