ARTICLES OF INCORPORATION

OF

COIN SIGN, INC.

I, the undersigned, being a natural person of legal age, do hereby desire to form a Corporation under the Laws of the State of Florida, and do hereby adopt the following Articles of Incorporation.

ARTICLE I  
NAME

The name of the Corporation shall be COIN SIGN, INC., a Florida Corporation.

ARTICLE II  
PRINCIPAL OFFICE OR MAILING ADDRESS


