ARTICLE I - NAME

The name of this corporation is PROFESSIONAL SOLUTIONS UNLIMITED, INC., with its principal office and address being located at 11298 Coral Key Drive, Boca Raton, Florida 33498 and its mailing address being 11298 Coral Key Drive, Boca Raton, Florida 33498.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Hundred (100) shares of \$1.00 par value common stock which shall be designated as "Common Shares".

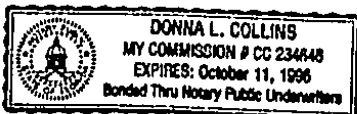
