ARTICLES OF INCORPORATION

Article I - Corporate Name

The name of this corporation is **WICKHAM, INC.**

Article II - Nature of Business and Powers

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III - Capital Stock

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 500 shares of common stock having a par value of one dollar (\$1.00) per share.

Article IV - Term of Existence

This Corporation shall have perpetual existence commencing upon filing of these Articles.

Article V - Registered Agent and Initial Registered Office

The Registered Agent and the street address of the Initial Registered Office of this Corporation in the State of Florida shall be Luther M. Taylor, 11165 Old Harbour Road, North Palm Beach, FL 33408.

Article VI - Principal Place of Business & Mailing Address

The principal place of business and mailing address of the corporation in the State of Florida shall be Post Office Box 33301, Palm Beach Gardens, FL 33420-3301.

Article VII - Board of Directors

This corporation shall have 1 director(s) initially. The number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but shall never be less than one.

Article VIII - Initial Director

The name(s) of the initial director(s) of this Corporation and their street addresses is: Luther M. Taylor, 11165 Old Harbour Road, North Palm Beach, FL 33420-3301.

The person(s) named as initial director(s) shall hold office for the first year of existence of this Corporation or until their successors are elected or appointed and have qualified, whichever occurs first.

Article IX - Incorporator

Article X - Amendment

These Articles of Incorporation may be amended in the manner provided by law. 
