ARTICLES OF INCORPORATION OF COMMAND TELECOMMUNICATIONS, INC.

ARTICLE I. NAME

The name of this corporation is:

COMMAND TELECOMMUNICATIONS, INC.

ARTICLE II. PURPOSE

This corporation is organized for the following purposes:

To engage in any or all lawful business for which a corporation may be incorporated under the laws of Florida.

ARTICLE III. POWERS

- a. To have a corporate seal, which may be altored at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed or in any other manner reproduced.
