## ARTICLES OF INCORPORATION

### ARTICLE I:

The undersigned, Tianshu Chu, whose present address is 2001 SW 16th Street, Apt.# C-27, Gainesville, Florida, being at least eighteen years of age, acting as incorporator, does hereby form a corporation under and by virtue of General Laws of the State of Florida authorizing the formation of corporations.

### ARTICLE II:


