## ARTICLES OF INCORPORATION OF ADULT PLATINUM SERVICES, INC.

The undersigned, acting as Incorporator of a corporation of under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

#### NAME OF CORPORATION

The name of the corporation shall be ADULT PLATINUM SERVICES, INC.

#### ARTICLE II

#### TERM

This corporation is to exist perpetually.

#### ARTICLE III

#### PURPOSE

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

#### ARTICLE IV

#### CAPITAL STOCK

The aggregate number of shares of stock that this corporation is authorized to issue is one thousand (1,000) shares of common stock being the only stock authorized to be issued and having a par value of one (\$1.00) dollar per share.
