# ARTICLES OF INCORPORATION

OF

ARTICLE I. NAME

The name of the corporation is ROYAL DESIGN MIRRORS, INC.

#### ARTICLE II. PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.
