ARTICLES OF INCORPORATION

THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is SCOOBIES DRIVE-IN RESTAURANTS, INC.

ARTICLE II - NATURE OF BUSINESS

To the same extent as natural persons might or could do, the Corporation shall have the power:

- A. To carry on any lawful business whatsoever which the Corporation may deem proper or convenient, or which may be intended directly or indirectly to promote the interests of the Corporation or to enhance the value of its property.

This Corporation is to have perpetual existence.

ARTICLE V - RESIDENT AGENT AND APDRESS

The street address of the initial registered office of the Corporation in the State of Florida and principal place of business shall be 31950 U.S. HWY 19 N., Palm Harbor, FL 34684 and the name of its initial Registered Agent at such address is Michael G. Perez. The corporation may have and establish offices, conduct business and promote its objectives within any part of the State of Florida, or in any state, District of Columbia, and territories and colonies of the United States and in foreign countries, as the Directors may designate.
