Recently I received a "Notice of Administrative Dissolution or Revocation" regarding my Corporation, Glenkay, Inc. I have attempted correspondence via regular mail and have not gotten any response, and am therefore sending this certified in an attempt to get this resolved.

This corporation has been in existence since 1977, and since that time my Annual Reports have been filed in a timely fashion. 1997 was no exception, I originally mailed my Report with Check #3697 in the amount of \$165.00 on January 3, 1997. Due to a computer crash and subsequent summary reconstruction, I was not aware that this check was in fact still outstanding.
