To whom it may concern,

Recently I received a "Notice of Administrative Dissolution or Revocation" regarding my Corporation, Glenkay, Inc. I have attempted correspondence via regular mail and have not gotten any response, and am therefore sending this certified in an attempt to get this resolved.

This corporation has been in existence since 1977, and since that time my Annual Reports have been filed in a timely fashion. 1997 was no exception, I originally mailed my Report with Check #3697 in the amount of \$165.00 on January 3, 1997. Due to a computer crash and subsequent summary reconstruction, I was not aware that this check was in fact still outstanding. In addition, knowing that I had filed the original return, paid no attention to the 2nd notice which was sent by your office.

The 1997 Annual Report, which was mailed on 1/3/97 was sent regular mail, and since I have never had any problems in the past, it did not occur to me to send it "return receipt". As per the "Statutory Citations" 607.1622 item (2), I would like to know what would constitute "Proof" for compliance. Having to pay \$750.00 for reinstatement, when I was in compliance by mailing my report and check for \$165.00 in early January is both unreasonable, as well as an unfair financial burden for my business.
