OF

The undersigned, acting as incorporator of a corporation pursuant to chapter 607, Florida Statutes, adopt the following articles of incorporation:

ARTICLE I

The name of the incorporation shall be:

ARTICLE II

The principal place of business and the mailing address of this incorporation shall be:

ARTICLE III

This incorporation is organized with the purpose to brick and tile installation.

ARTICLE IV

This incorporation is authorized to issue 100 shares of one dollar (\$1.00) par value common stock which shall be designated as common shares.
