EFFECTIVE DATE

The undersigned hereby forms a corporation under CHAPTER 607 of the laws of the State of Florida.

#### ARTICLE I. NAME AND PRINCIPAL BUSINESS ADDRESS

The name of the corporation shall be:

SPECIAL EYES DETECTIVE AGENCY, INC.
