The undersigned hereby forms a corporation under CHAPTER 607
of the laws of the State of Florida.

ARTICLE I. NAME AND PRINCIPAL BUSINESS ADDRESS

The name of the corporation shall be:

SPECIAL EYES DETECTIVE AGENCY, INC.

The address of the principal office of the Corporation shall be
3908 West San Luis Street; Tampa, Florida 33629; and the mailing
address shall be Post Office Box 13601; Tampa, Florida 33681.

ARTICLE II. NATURE OF BUSINESS

The corporation may engage or transact in any or all lawful
activities or business permitted under the laws of the United
States, the State of Florida or any other state, country,
territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that the corporation
is authorized to have outstanding at any one time is 1,000 shares

of common stock having a par value of one dollar per share. The corporation elects to have preemptive rights.

ARTICLE IV. REGISTERED OFFICE ADDRESS

ARTICLE V. COMMENCEMENT AND TERM OF EXISTENCE

The corporation shall commence existence at 12:01 a.m. on Wednesday, September 4, 1993, and shall continue in perpetuity.

The corporation shall initially have two directors, who shall hold office for the first year of the corporation or until their successors are elected or appointed and whose names and addresses are as follows:

ARTICLE VII. SHAREHOLDER MEETINGS

At any shareholders' meeting, properly called, a majority of shares entitled to vote shall constitute a quorum. When any item

of business is required to or may be voted on by shareholders, an affirmative vote of a majority of those shares entitled to vote shall be required to constitute the act of the shareholders. Shareholders shall be entitled to cumulate their votes for directors.

ARTICLE VIII. BOARD OF DIRECTORS MEETINGS


At any Board of Directors meeting, properly called, a two-thirds majority of the Board shall constitute a quorum. When any item of business is required to or may be voted on by the Board of Directors, an affirmative vote of a two-thirds majority of the Board shall be required to constitute the act of the Directors.
