ARTICLES OF INCORPORATION

or

ARTICLE T - NAME:

The name of this corporation is: ENGINEERING TECHNIQUES, INC., hereinafter referred to as the ("Corporation").

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:
