

ARTICLES OF INCORPORATION

Article I - Name

The name of this corporation is J & G BARNES, INC. The initial street address of the principal office is 1529 Lisenby Avenue, Panama City, Florida, 32405 and the mailing address is 1529 Lisenby Avenue, Panama City, Florida, 32405.

Article II - Duration

This corporation shall exist perpetually, commencing with the date of execution and acknowledgment of these Articles.
