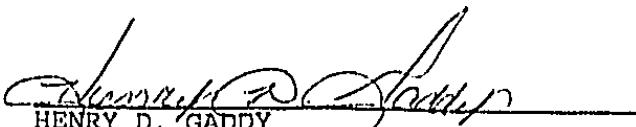
ARTICLE IX - BY-LAWS

ARTICLE X - AMENDMENT

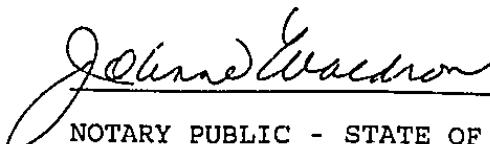

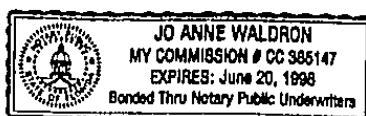

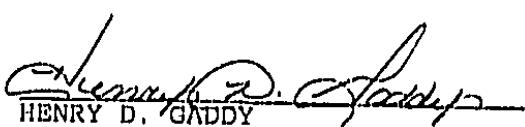
