

ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, subscribed to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

U.S. PUBLIC TELEPHONE COMPANY, INC.

and its initial post office address and its principal office for the conduct of business is:

The Board of Directors may from time to time move the principal office to any other address in Plorida.

ARTICLE II

The general purpose of the corporation is to engage in any activities or businesses permitted under the laws of the United States and Florida, including, but not limited to, the installation, maintenance and operation of pay telephones and pay telephone systems.

The term for which this corporation shall exist shall be perpetual and the business of the corporation shall be conducted, carried on and managed by the officers of this corporation and


