2. The Articles of Incorporation of the Corporation are hereby amended to change the name of the Corporation from GREEN PIECE WIRE ART, INC. to WELLS JACOBSON, INC. To effect such amendment, Article I of the Articles of Incorporation is hereby amended and restated in its entirety to read as follows:

"ARTICLE I - NAME

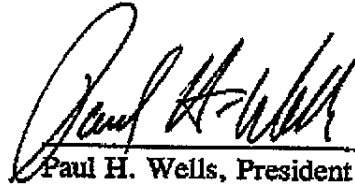
The name of the Corporation is **WELLS JACOBSON, INC.**, (hereinafter, the "Corporation")."
