# ARTICLES OF INCORPORATION OF S AND J MARKETING, INC.

The undersigned incorporator hereby makes, subscribes to, acknowledges and files these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit under the laws of the State of Plorida.

The time and date on which corporate existence of this corporation shall begin is 12:01 am (Eastern Standard Time) on September 6, 1996, and this corporation shall have continuous and perpetual existence thereafter.

# **ARTICLE III**

The general purposes for which the corporation is initially organized are as follows:

- a. Any business activity authorized by the laws of the State of Florida.
