# ARTICLES OF INCORPORATION OF ALEXA'S SUB SHOPPE, INC.

## ARTICLE I - NAME

The name of this corporation is: ALEXA's SUB SHOPPE INC.

## ARTICLE II - PURPOSE

This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated in the State of Florida.

# ARTICLE III - CAPITAL STOCK
