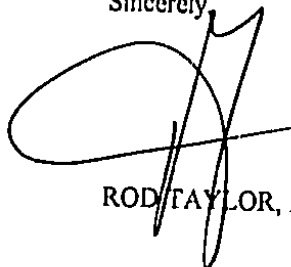

ARTICLE I - Name and Principal Place of Business

The name of this corporation is VAN M. GOLMONT, JR., INC., and its principal of business is 17431 East Carnegie Circle, Fort Myers, Florida 33912.

ARTICLE II - Purpose

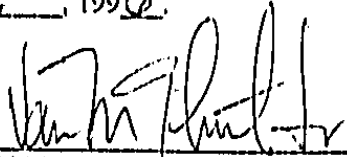

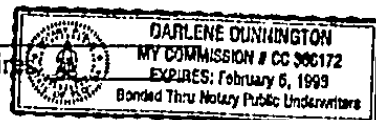

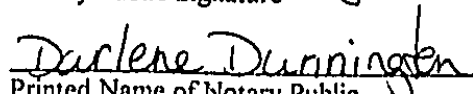
