The corporation may engage in any activity or business permitted

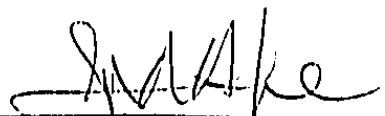

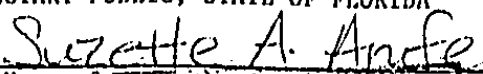
FOURTH: The amount of capital with which the corporation may begin business will not be less than FIVE HUNDRED DOLLARS (\$500.00).

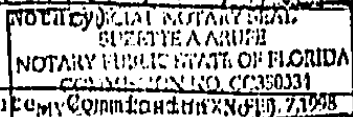

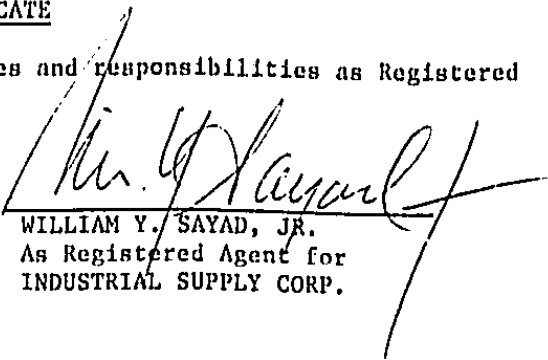

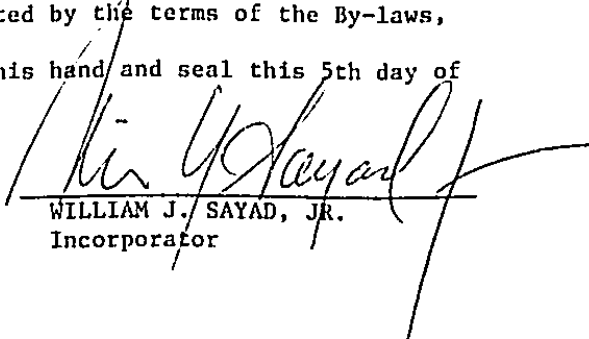
