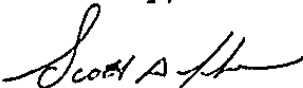

ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT hereby adopts the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of the corporation is SCOTT A. YOKE, INC.

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSE

In accordance with Section 607.167, Florida Statutes, the date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

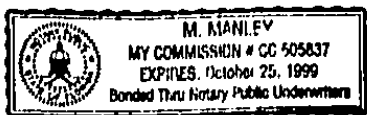
