ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is BHAVANI, INC., and the principal address and principal place of business is 5006 East Broadway Avenue, Tampa, Florida 33619.

ARTICLE II - REGISTERED OFFICE AND AGENT
