We, the undersigned incorporators, hereby ourselves together and make, subscribe, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for the purpose of forming a Corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME


ARTICLE IX - INDEMNIFICATION

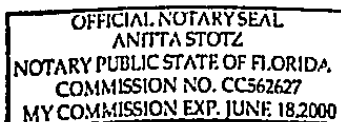


