ARTICLES OF INCORPORATION OF BLAK JACK TOBACCO, INC.

The undersigned incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I Name and Address

- (a) To have perpetual succession by its corporate name,
- (b) To sue and be sued, complain, and defend in its corporate name;
