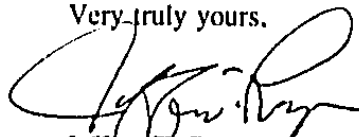

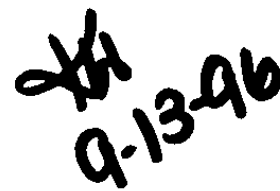

ARTICLES OF INCORPORATION  
OF

THE UNDERSIGNED, acting as sole incorporator of a corporation to be formed under the Florida *Business Corporation Act, Chapter 607*, Florida Statutes, adopts the following Articles of Incorporation:

FIRST: The name of the corporation (the "Corporation") is:

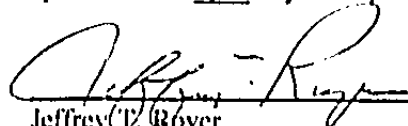

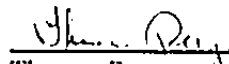
