

ARTICLES OF INCORPORATION

FOR

RIDE WITH PRIDE, INC.

The Undersigned, acting as incorporators of this business corporation pursuant to Chapter 617 of the Florida Statutes, hereby forms a Not for Profit Corporation under the laws of the State of Florida and adopts the following Articles of Incorporation for this corporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be RIDE WITH PRIDE, INC.

ARTICLES II - TERM OF EXISTENCE

This corporation shall begin its corporation existence as of the 9th day of September, 1996, and shall exist perpetually.

ARTICLES III - GENERAL PURPOSE

The general purpose for which this corporation is organized shall be promotion and furtherance of physically challenged riding program, charitable and otherwise. The business of the corporation shall be limited to the foregoing activities.

ARTICLE IV

REGISTERED OFFICE, REGISTERED AGENT AND PRINCIPAL OFFICE

The street address of the initial Registered Office of the corporation in the State of Florida will be 1340 Tuskawilla Road, Winter Springs, Florida 32708, and the name of the initial Registered Agent as such address is GRACE ANNE GLAVIN, ESQUIRE.

ARTICLE V - DIRECTORS AND INCORPORATION

A. The initial number of Directors of this corporation shall be three (3).

B. The number of Directors may be increased or diminished from time to time with by-laws adopted by the shareholders, but shall never be less than one.


ARTICLE VII - INDEMNIFICATION

The corporation shall indemnify any incorporators, officer or director, of any former incorporator, officer or director, to the full extent permitted by law.




