The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate to form a corporation under the laws of the State of Florida and heroby does adopt the following Articles of Incorporation.

ARTICLE I.

The name of this corporation is: FUTONS & FURNITURE WAREHOUSE, INC.

ARTICLE II.

The general nature of the business to be transacted by this Corporation is to engages.

Revery aspect and phase of FURNITURE Wholesale and Retail, Sales and Sorrices. in every aspect and phase of FURNITURE Wholesale and Retail Sales and Services, to purchase, lease, rent or otherwise acquire suitable property, and to buy and sell any and all commodities in connection with such operations.
