# ARTICLES OF INCORPORATION OF K & K MAINTENANCE & MANAGEMENT, INC.

#### KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, this day for the purpose of forming a corporation under the laws of the State of Florida do hereby adopt Articles of Incorporation as follows:

#### ARPICLE I - NAME

The name of this corporation shall be K & K MAINITENANCE & MANAGEMENT, INC.

# ARPICLE II - ADDRESS OF CORPORATE OFFICE
