ARTICLES OF INCORPORATION

II

IN WITNESS WHEREOF, I have hereunto set my hand and seal of office.

I, the undersigned incorporator, to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

FIRST: The name of the corporation is:

SECOND: The corporation may engage in the transaction of any and all lawful activity or business for which corporations may be incorporated and permitted under the laws of the United States and of the State of Florida.

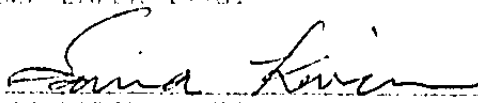
