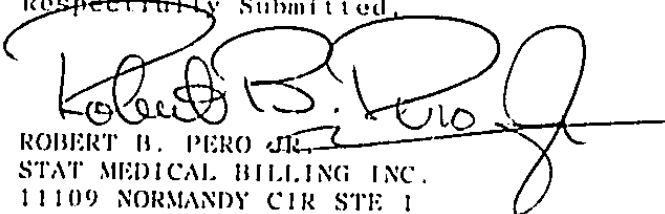

ARTICLES OF INCORPORATION

of

STAT MEDICAL BILLING INC.

ARTICLE I NAME

The name of the corporation is STAT MEDICAL BILLING INC.
and whose principal office location is 11109 NORMANDY CIR STE 1
TEMPLE TERRACE, FL 33617

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

BUSINESS SERVICES and shall include the
transaction of any and all lawful business for which corporations may be
Incorporated under State of Florida Statutes.

ARTICLE IV - CAPITAL STOCK

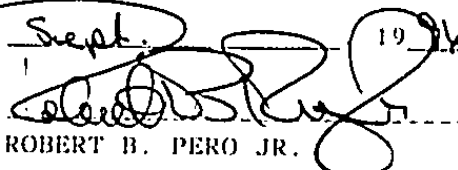

ARTICLE IX - POWERS

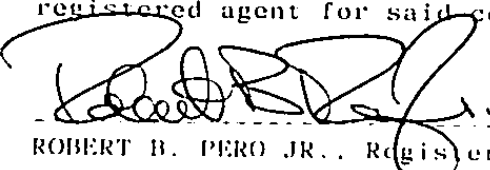
This corporation shall have all of the corporate powers enumerated

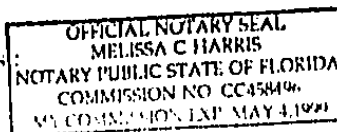
