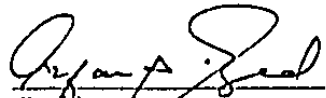
6. **PURPOSE:** The purpose of this corporation is to engage in the practice of Public Accounting allowed under laws of the state of Florida and the United States of America.
