ARTICLE I

The name of this corporation is XL Auto Paint & Body, Inc.

ARTICLE B

This corporation shall have perpetual existence, commencing on the date the corporate charter is issued by the Secretary of State of the State of florida.

ARTICLE III

The nature of the business or businesses to be transacted by this corporation is:

- a. To engage in the business of painting and performing body work on any and all kinds of automobiles, trucks, and similar conveyances; to own shares in and to manage corporations carrying out the aforedescribed activities; and to generally do anything necessary and proper to assist in these activities.
- b. To buy, sell, exchange, lease, lend, import, export, manufacture, repair, service, improve, manage, deal and trade in any and all kinds of property, real, personal or mixed, of whatever nature and whersoever situate, as principal, agent, correspondent, or broker for the corporation's account, of for the account of others.
