

**OF**

**ARTICLE I - NAME**

The name of this corporation is THE TOURIST NETWORK, INC.  
P.O. Box 9556, Panama City, FL 32417

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing with the date of filing with the Secretary of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue 1000 shares of One Dollar (\$1.00) par value common stock.
