ARTICLES OF INCORPORATION

THE LEARNING GARDEN, INC.

The undersigned subscriber to these ARTICLES OF INCORPORATION, a natural person, competent to contract, hereby subscribes to this instrument so as to form a corporation under the Laws of the State of Florida.

1. The name of the corporation is:

 principal office to any other address in Florida.
- 3. The maximum number of shares that this corporation is authorized to have outstanding at any one time is:

FIFTY SHARES OF COMMON STOCK WITHOUT NOMINAL OR PAR VALUE

The consideration to be paid for each share shall be fixed by the Board of Directors.

- 4. In pursuance of Chapter 607, Florida Statutes, the following is submitted in compliance with said Act, that THE LEARNING GARDEN, INC. desiring to organize under the Laws of the State of Florida, with its registered office as indicated in the Articles of Incorporation, at 4541 S.W. 64th Ct., Miami, FL 33155, has named CRISTINA GUANCHE as its registered agent in this state.
- 5. The name(s) and address(es)of the incorporator(s) to these Articles of Incorporation, the number of shares each agrees to take, and the value of the consideration therefore is (are):

- 6. The general nature of the business to be transacted by this corporation is:
 - a) To engage in the care and education of children.
 - b) To conduct business in, have one or more offices in and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses, in the State of Florida and in all other states and countries.

- c) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.
- d) To purchase the corporate assets of now existent corporations and engage in the same or other character of business.
- e) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the capital stock of, or any bonds, securities, or other indebtedness created by any other corporation of the State of Florida or any other state or government, and while the owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
- f) To act as agent for any person, firm or corporation, and to enter into every type of contract which might seem to be in the corporation's interest.
- g) To do any and all things herein before enumerated for itself or on account of others, and to make and perform contracts for doing any thereof; to have and exercise all the rights now or hereafter conferred by the Laws of the State of Florida now in force or any amendment or amendments thereto.

The foregoing enumeration of the objects, purposes and powers is not intended and shall not be construed or held to prohibit or limit the exercise of any further rights or powers which may now or hereafter be allowed by the Corporation Laws of the State of Florida now in force or any amendment or amendments thereto.

- 8. The corporation herein formed is to exist perpetually.
- This corporation shall have 1 Director initially. The number of Directors may be increased or diminished from time to time.

The Board of Directors is authorized to adopt BY-LAWS, including provisions to cover the issuance of stock certificates, and prohibitions against the transfer of the stock of the corporation and of the pre-emptive rights to such stock, provided such BY-LAWS are not contrary to the Laws of the State of Florida.
