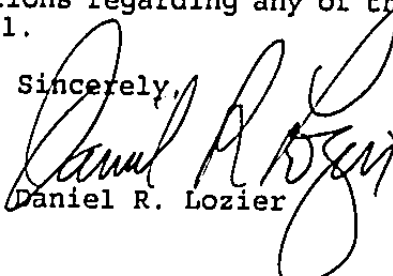

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is Moonlighters, Inc., whose principal place of business is 558 Barkwood Drive, Pace, Florida 32571. The mailing address is 558 Barkwood Drive, Pace, Florida 32571.

ARTICLE II

DURATION

The duration of this corporation is perpetual.

ARTICLE III

PURPOSE

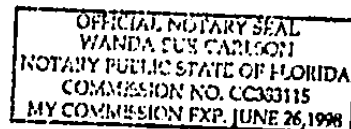
