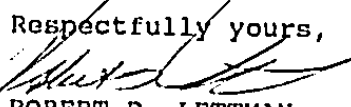

ARTICLES OF INCORPORATION
OF

A&P OF PINE BAY, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

A&P of Pine Bay, Inc.

The principal place of business of this corporation shall be 10100 W. Sample Road, Suite #205, Coral Springs, Florida 33065.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

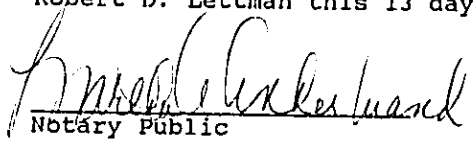

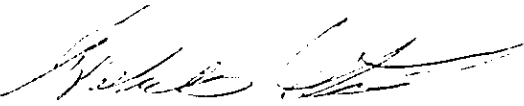
