The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a professional association under the laws of the State of Florida pursuant to the provisions of Chapter 621, Florida Statutes, otherwise known as the "Professional Services Corporation Act" of the State of Florida, and Part II, Chapter 607, Florida Statutes.

ARTICLE 1

NAME

The name of this corporation is:

FITZGERALD, HAWKINS, MAYANS & COOK, P.A.

ARTICLE II

PURPOSE

This corporation may engage in the practice of law which is permitted under the laws of the United States and of the State of Florida; to engage in any activities which will facilitate and promote the practice of law through its officers and employees; and to invest and reinvest its funds in real estate, mortgages, stocks, bonds and any other type of investments within the meaning of Section 621.08 of the Professional Services Corporation Act; and to purchase and own real and personal property necessary for the rendering of professional services within the practice of law.
