ARTICLE VI: INITIAL OFFICERS

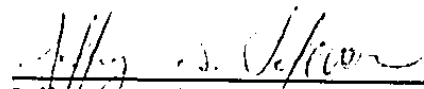
There shall be one initial officer of the corporation. The name, address and title of the officer is:

ARTICLE VII: FISCAL YEAR

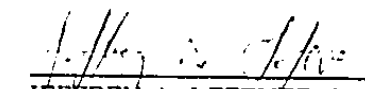
The fiscal year of the corporation shall end on December 31st of each calendar year.

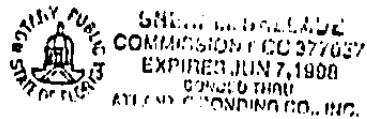
