1. Name. The name of the corporation is Atlas Worldwide Leasing, Inc.

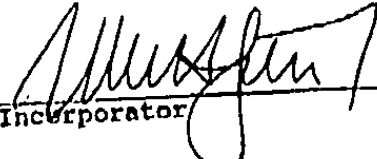

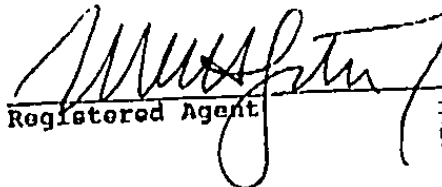
