These Articles of Incorporation may be amended in the manner provided by law, and any right conferred upon the shareholders is subject to this reservation. Every amendment shall be approved by the Board of Directors, proposed by them to the shareholders, and approved at a stockholders meeting by a majority of the stock entitled to vote thereof, unless all of the directors and shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
