ARTICLES OF INCORPORATION

OF

The undersigned, for the purposes of forming a corporation under Florida law hereby adopt the following Articles of Incorporation:

ARTICLE ONE  
NAME

The name of the corporation is OCEAN FLIGHT ACADEMY, INC.

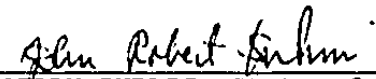
